Amend the bill by striking out the title and substituting the following:

Further amend the bill in section 1 in that part designated "~~§6208-B.~~" in the first line (page 1, line 5 in L.D.) by striking out the following: "Approval" and inserting in its place the following: 'Review'

Further amend the bill in section 1 in that part designated "~~§6208-B.~~" in the first paragraph in the first line (page 1, line 8 in L.D.) by striking out the following: "Approval" and inserting in its place the following: 'Review'

Further amend the bill in section 1 in that part designated "~~§6208-B.~~" in the first paragraph by striking out all of the last sentence (page 1, lines 12 and 13 in L.D.)
