HOUSE AMENDMENT "B" to COMMITTEE AMENDMENT "A" to S.P. 49, L.D. 126, Bill, "An Act to Amend the Membership of the Propane and Natural Gas Board"

Amend the amendment by striking out all of the first indented paragraph after the title (page 1, lines 22 to 24 in amendment) and inserting in its place the following:

'Amend the bill in section 1 in subsection 1 in the first line (page 1, line 6 in L.D.) by striking out the following: "8 9" and inserting in its place the following: '8'

Further amend the bill in section 1 in subsection 1 in paragraph A in the first line (page 1, line 22 in L.D.) by striking out the following: "Five members representing industry, 3" and inserting in its place the following: 'Five Four members representing industry, 3 2' '

Further amend the amendment by striking out all of the 3rd indented paragraph after the title (page 1, lines 33 and 34 in amendment)

Further amend the amendment by striking out all of section 2 (page 1, lines 36 to 49 and page 2, line 1 in amendment)
