Further amend the amendment by striking out all of the 3rd 34 indented paragraph after the title (page 1, lines 33 and 34 in amendment)

Further amend the amendment by striking out all of section 2 38 (page 1, lines 36 to 49 and page 2, line 1 in amendment)
