Be it enacted by the People of the State of Maine as follows:
Sec. 1. 34-A MRSA c. 9, sub-c. 6 is enacted to read:
SUBCHAPTER 6
INTERSTATE COMPACT FOR ADULT OFFENDER SUPERVISION
§9871. Short titleArticle 1
This subchapter may be known and cited as the "Interstate Compact for Adult Offender Supervision."
§9872. DefinitionsArticle 2
As used in this subchapter, unless the context otherwise indicates, the following terms have the following meanings.
1. Adult. "Adult" means both an individual legally classified as an adult and a juvenile treated as an adult by court order, statute or operation of law.
2. Bylaws. "Bylaws" means those bylaws established by the
interstate commission for its governance or for directing or controlling the interstate commission's actions or conduct.
3. Commissioner. "Commissioner" means the voting representative of each compacting state appointed pursuant to section 9873.
4. Compact administrator. "Compact administrator" means the individual in each compacting state appointed pursuant to the terms of this compact responsible for the administration and
management of the state's supervision and transfer of offenders subject to the terms of this compact, the rules adopted by the interstate commission and policies adopted by the state council
under this compact.
5. Compacting state. "Compacting state" means any state that has enacted the enabling legislation for this compact.
6. Interstate commission. "Interstate commission" means
the Interstate Commission for Adult Offender Supervision established in this subchapter.
7 Nomber "Nomber" menne the commissioner of a commission
7. Member. "Member" means the commissioner of a compacting state or a designee who is a person officially connected with the commissioner.

	8. Noncompacting state. "Noncompacting state" means any

	9. Offender. "Offender" means an adult placed under, or
6	subject to, supervision as the result of the commission of a
8	criminal offense and released to the community under the

 10 commission is entitled to one vote. A majority of the compacting states constitutes a guorum for the transaction of business,
 12 unless a larger guorum is required by the bylaws of the interstate commission.

5. Meetings. The interstate commission shall meet at least once each calendar year. The chair may call additional meetings and, upon the request of a majority of the members, shall call additional meetings. Public notice must be given of all meetings and meetings are open to the public.

6. Executive committee. The interstate commission shall 22 establish an executive committee that includes commission officers, members and others as determined by the bylaws. The executive committee has the power to act on behalf of the 24 interstate commission during periods when the interstate 26 commission is not in session, with the exception of rulemaking or amendments to the compact. The executive committee oversees the day-to-day activities managed by the executive director and 28 interstate commission staff; administers enforcement and 30 compliance with the provisions of the compact, its bylaws and as directed by the interstate commission; and performs other duties 32 as directed by the interstate commission or set forth in the bylaws.

§9874. State council--Article 4

Each member state shall create a State Council for Interstate Adult Offender Supervision that is responsible for the 38 appointment of the commissioner who serves on the interstate 40 commission from that state. Each state council shall appoint as its commissioner the compact administrator from that state to serve on the interstate commission in such capacity under or 42 pursuant to applicable law of the member state. While each 44 member state may determine the membership of its own state council, its membership must include at least one representative from the legislative, judicial and executive branches of 46 government; victims groups; and the compact administrator. Each 48 compacting state retains the right to determine the qualifications of the compact administrator who must be appointed by the state council or by the governor in consultation with the 50

Except as otherwise provided in this compact and unless a greater percentage is required by the bylaws, in 28 order to constitute an act of the interstate commission, the act must have been taken at a meeting of the interstate commission 30 and must have received an affirmative vote of a majority of the members present.

2. Members' rights. Each member of the interstate 34 commission has the right and power to cast a vote to which the compacting state is entitled and to participate in the business and affairs of the interstate commission. - 26 **1. Other laws.** This compact does not prevent the enforcement of any other law of a compacting state that is not inconsistent with this compact. All compacting states' laws conflicting with this compact are superseded to the extent of the 30 conflict.
- 32 2. Binding effect of compact. All lawful actions of the interstate commission, including all rules and bylaws promulgated
 34 by the interstate commission, are binding upon the compacting states. All agreements between the interstate commission and the
 36 compacting states are binding in accordance with their terms.
- 38 Upon the request of a party to a conflict over meaning or interpretation of interstate commission actions, and upon a 40 majority vote of the compacting states, the interstate commission may issue advisory opinions regarding such meaning or 42 interpretation.

	Sec. 2. Legislative intent. The text and numbering of the
6	Interstate Compact for Adult Offender Supervision have been
	changed to conform to Maine statutory conventions. The changes

	that this Act be interpreted as substantively the same as the
10	original compact.
