Further amend the amendment by striking out all of sections 11 and 12 and inserting in their place the following:

'Sec. 11. Funding. Resolved: That the commission shall seek 8 outside funds to fully fund all costs of the commission. If sufficient outside funding has not been received by August 15, 2003 to fully fund all costs of the commission, no meetings are 10 authorized and no expenses of any kind may be incurred or reimbursed. Contributions to support the work of the commission 12 may not be accepted from any party having a pecuniary or other 14 vested interest in the outcome of the matters being studied. Any person, other than a state agency, desiring to make a financial 16 or in-kind contribution must certify to the Legislative Council that it has no pecuniary or other vested interest in the outcome 18 of the study. Such certification must be made in the manner prescribed by the Legislative Council. All contributions are 20 subject to approval by the Legislative Council. All funds accepted must be forwarded to the Executive Director of the Legislative Council along with an accounting record that includes 22 the amount of funds, the date the funds were received, from whom 24 the funds were received and the purpose of and any limitation on the use of those funds. The Executive Director of the 26 Legislative Council administers any funds received by the commission. The executive director shall notify the chairs of 28 the commission when sufficient funding has been received; and be it further

Fiscal Detail and Notes

This amendment reduces the cost of this study by \$1,400 in fiscal year 2003-04 and provides that outside funding must be received by August 15, 2003 or the commission may not go forward. The projected costs for the general operating expenses of the Commission To Study the Scope and Quality of Citizenship Education is \$4,920 in fiscal year 2003-04.
