HOUSE AMENDMENT "A" to COMMITTEE AMENDMENT "A" to H.P. 372, L.D. 483, Bill, "An Act To Make Supplemental Appropriations and Allocations for the Expenditures of State Government and To Change Certain Provisions of the Law Necessary to the Proper Operations of State Government for the Fiscal Year Ending June 30, 2003"

Amend the amendment by striking out all of Part K, section 2.

Further amend the amendment by relettering or renumbering any nonconsecutive Part letter or section number to read consecutively.

SUMMARY

This bill, as amended by Committee Amendment "A," transfers \$78,000 from the Emergency Response Operations, Other Special Revenue Funds account in the Department of Defense, Veterans and Emergency Management to the unappropriated surplus of the General Fund no later than June 30, 2003. This amendment strikes that provision.

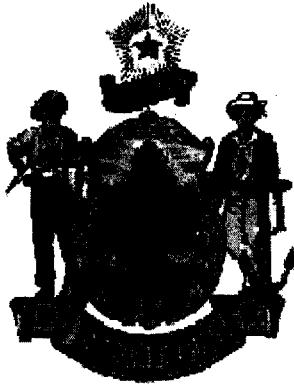
