28	3. Rules. The board shall adopt rules to prescribe maximum attorney's fees and the manner in which the amount is determined
30	and paid by the employee. The Except for fees paid under section
32	<u>318, the</u> maximum attorney's fees prescribed by the board in a case tried to completion may not exceed 30% of the benefits accrued, after deducting reasonable expenses incurred on behalf
34	of the employee, or be based on a weekly benefit amount after coordination that is higher than 2/3 of the state average weekly
36	wage at the time of injury. The board may by rule allow attorney's fees to be increased above or decreased below the
38	amount specified in the rule when in the discretion of the board that action is determined to be appropriate.'
