This amendment clarifies that the State is required to report, in the same manner as the State is required to report information about newly hired employees, the information concerning persons who work for the State under contract. Similarly, contractors with the State and their subcontractors must report the information for independent contractors. In these situations, the date of birth of the contractor or subcontractor is not required to be reported. In addition, the contractor's or subcontractor's taxpayer identification number may be substituted for the contractor's or subcontractor's social security number.
