Further amend the bill by striking out all of section 3.

## **SUMMARY**

10 The amendment amends the definition of "amalgam separator system" to include a device that removes dental amalgam from the 12 waste stream prior to its discharge to a private septic system located at a dental facility. The amendment also requires dental amalgam separators to meet a minimum removal efficiency of 95% if 14 installed prior to March 20, 2003 or 98% if installed on or after 16 March 20, 2003 as determined through testing in accordance with standards of the International Organization for Standardization 18 in effect on the date the system is installed. The amendment requires dentists to maintain, for a period of 3 years, all 20 shipping records for replacement filters and written documentation to demonstrate that the amalgam separator system 22 has been properly inspected and maintained.
