This bill provides funding for the Bureau of Health, within 34 the Department of Human Services, to make grants to federally qualified health centers, Indian Health Service - supported 36 centers and the Maine Primary Care Association to support health care safety net programs. The additional funding is offset by an 38 increase in the cigarette tax from \$1 to \$1.05 per pack.
