SUMMARY

This bill repeals the law that allowed the conversion of the former Blue Cross and Blue Shield of Maine from a nonprofit hospital and medical service organization and public charity to a for-profit stock company. It also requires the approximately \$88,000,000 in assets resulting from the conversion to be turned over to the General Fund by October 1, 2003.
