 3. Subcontractor's certification of intent to comply; proof of insurance. Before a contractor enters into a contract with a subcontractor, the contractor must obtain a document from the subcontractor certifying under oath that the subcontractor will
 comply with the requirements of subsection 1. The subcontractor shall also provide written proof that the subcontractor complies
 with subsection 1, paragraphs B, C and D. The contractor shall deliver copies of the certification and proof to the public
 official in charge of the public improvement project.

14 **4. Failure to provide certification before contract is** signed. A public official may not award a contract to any 16 contractor who fails to comply with subsection 2. A contractor may not award a subcontract to any subcontractor who fails to 18 comply with subsection 3.

5. Failure to comply during term of contract. A contractor must comply at all times during the term of the contract with the requirements of subsection 1 and must weekly certify under oath and in writing that the contractor complies with those
 requirements. A subcontractor must comply at all times during the term of the contract with the requirements of subsection 1
 and must weekly certify under oath and in writing that the subcontractor complies with the subcontractor complies with those requirements.

6. Penalties for failure to comply during term of
 30 contract. A contractor or subcontractor who fails to comply with
 subsection 5 is subject to the penalties set forth in this
 32 subsection, as determined by the public official in charge of the
 public improvement project. A contractor is liable for
 34 noncompliance by any person who is performing work under a
 subcontract with the contractor.

- A. The public official in charge of the public improvement
  38 project may order the contractor or subcontractor to cease work until compliance is attained.

- 42 <u>B. The public official in charge of the public improvement</u> 42 <u>project may withhold payment due under any contract or</u> <u>subcontract until compliance is obtained.</u>
- 46 <u>C. The public official in charge of the public improvement</u> 46 <u>project may permanently remove the contractor or</u> <u>subcontractor from the job.</u> 48
- D. The public official in charge of the public improvement project may assess liquidated damages against the contractor

or subcontractor in the amount of 5% of the dollar value of the contract.

- 7. Disbarment from future work. A contractor or subcontractor that has violated any provision of this section is
   barred from performing work on another public improvement project for 6 months for the first violation, 3 years for the 2nd
   violation and permanently for a 3rd violation.

## SUMMARY

This bill enacts criteria that must be met by any contractor 14 subcontractor performing work on a public improvement or project. The bill requires that the contractor or subcontractor comply with prevailing wage laws, provide employer-paid health 16 and hospitalization benefits to employees, maintain apprenticeship programs and properly classify employees for 18 purposes of workers' compensation, unemployment and other tax The bill provides penalties for contractors or 20 purposes. subcontractors who fail to comply with the requirements of the law, including refusal to allow the person to bid on or perform 22 work on future projects, liquidated damages, withholding of payments under the contract and cessation of work on the 24 Contractors are liable for noncompliance by their project. subcontractors. 26
