Resolve, to Create a Task Force to Implement the 1991 Report of the President's and Speaker's Blue Ribbon Commission on Children and Families

Presented by Representative O'BRIEN of Augusta. Cosponsored by Senator BENNETT of Oxford. **Emergency preamble. Whereas,** Acts and resolves of the 2 Legislature do not become effective until 90 days after adjournment unless enacted as emergencies; and

Whereas, the study required by this resolve must be initiated before the 90-day period expires in order that the study may be completed and a report submitted for the next legislative session; and

10 Whereas, in the judgment of the Legislature, these facts create an emergency within the meaning of the Constitution of 12 Maine and require the following legislation as immediately necessary for the preservation of the public peace, health and 14 safety; now, therefore, be it

Sec. 1. Task force established. Resolved: That the Task Force to Implement the 1991 Report of the President's and Speaker's Blue
Ribbon Commission on Children and Families, referred to in this resolve as the "task force," is established; and be it further

Sec. 2. Task force membership. Resolved: That the task force consists of 10 members as follows:

- 24 A. The President of the Senate;
- 26 B. The Speaker of the House;

- 28 C. The Majority Leader of the Senate;
- 30 D. The Assistant Majority Leader of the Senate;
- 32 E. The Minority Leader of the Senate;
- 34 F. The Assistant Minority Leader of the Senate;
- 36 G. The Majority Leader of the House of Representatives;
- 38 H. The Assistant Majority Leader of the House of Representatives;
- I. The Minority Leader of the House of Representatives; and
- J. The Assistant Minority Leader of the House of 44 Representatives; and be it further
- 46 Sec. 3. Chairs. Resolved: That the President of the Senate and the Speaker of the House of Representatives are the chairs of 48 the task force; and be it further

Sec. 4. Convening of task force. Resolved: That the chairs shall call and convene the first meeting of the task force no later than 45 days after adjournment of the First Regular Session of the 121st Legislature; and be it further

6 Sec. 5. Duties. Resolved: That the task force shall create a plan to implement the recommendations of the 1991 Report of the 8 President's and Speaker's Blue Ribbon Commission on Children and Families; and be it further

Sec. 6. Staff assistance. Resolved: That, upon approval of the Legislative Council, the Office of Policy and Legal Analysis shall provide necessary staffing services to the task force; and be it further

16 Sec. 7. Compensation. Resolved: That the members of the task force are entitled to receive the legislative per diem, as 18 defined by the Maine Revised Statutes, Title 3, section 2, and reimbursement for travel and other necessary expenses related to 20 their attendance at meetings of the commission; and be it further

Sec. 8. Report. Resolved: That the task force shall submit 22 together with any recommended implementing its report, legislation, to the Joint Standing Committee on State and Local 24 Government no later than November 3, 2003. The task force is not authorized to introduce legislation. Following receipt and 26 review of the report, the joint standing committee may report out a bill to the Second Regular Session of the 121st Legislature. 28 If the task force requires an extension of time to complete its report, it may apply to the Legislative Council, which may grant 30 the extension; and be it further

32 32 32 Sec. 9. Task force budget. Resolved: That the chairs of the 34 task force, with assistance from the task force staff, shall administer the task force's budget. Within 10 days after its 36 first meeting, the task force shall present a work plan and proposed budget to the Legislative Council for its approval. The 38 task force may not incur expenses that would result in the task force exceeding its approved budget.

- Upon request from the task force, the Executive Director of the Legislative Council or the Executive Director's designee shall promptly provide the task force chair and staff with a status report on the task force budget, expenditures incurred and paid and available funds.

4	This resolve creates the Task Force to Implement the 1991 Report of the President's and Speaker's Blue Ribbon Commission on

8	House and Senate majority and minority leaders. The task force is required to report to the joint standing committee of the
10	Legislature having jurisdiction over state and local government matters by November 3, 2003.
