The fee for a biennial 4-year renewal is \$200 \$400, which is refundable upon denial of renewal. The fee for an investigative assistant's license is \$300 \$600, of which \$100 \$200 must be submitted with the application and \$200 \$400 must be submitted upon issuance of the license.

§8121. Confidentiality when under contract to law enforcement agency

A private investigator or investigative assistant who enters into a written contract with a law enforcement agency in this

State to provide investigative services or consultation to the law enforcement agency is subject to the same provisions of law regarding confidentiality as are employees of the law enforcement agency with which the private investigator or investigative assistant is under contract.'

- This amendment replaces the bill. The amendment does the following:
- 1. It changes the time when a private investigator's license may be renewed after initial licensure from every 2 to every 4 years and doubles the renewal fee to \$400;
- 2. It changes the term of an investigative assistant's license from one year with a possibility of a 6-month extension to 2 years and doubles the fee to \$600;
- 3. It clarifies that presentation of a badge by a private investigator or an investigative assistant to cause another person to believe that the private investigator or investigative assistant is a sworn peace officer is a Class D crime; and

4. It clarifies that a private investigator or investigative assistant who contracts with a state law enforcement agency is bound by that agency's confidentiality obligations.

Fiscal Detail and Notes

Changing the manner and terms of how private investigator licenses are renewed will result in the redistribution of General Fund revenues collected by the Department of Public Safety from license fees; the department will collect additional amounts of \$32,000 and \$51,000 in fiscal years 2003-04 and 2004-05, respectively. In the long term, these revenue increases are offset by revenue losses of the same amounts in fiscal years 2005-06 and 2006-07.
