SUMMARY

ł.

This amendment strikes language from the bill requiring a 4 motor vehicle dealer to pay a \$300 fee for each dealer plate issued for personal use. Like the bill, the amendment requires 6 that a motor vehicle dealer must be denied renewal of the license if the dealer sold fewer than 4 motor vehicles in the previous 8 license year, but the amendment also prevents a motor vehicle dealer who is denied license renewal from reapplying for one 10 year. The amendment also exempts a motor vehicle dealer who holds an auction business license from the provisions of the bill.
