SENATE AMENDMENT "G" to COMMITTEE AMENDMENT "A" to H.P. 973, L.D. 1319, Bill, "An Act Making Unified Appropriations and Allocations for the Expenditures of State Government, General Fund and Other Funds, and Changing Certain Provisions of the Law Necessary to the Proper Operations of State Government for the Fiscal Years Ending June 30, 2004 and June 30, 2005"

Amend the amendment in Part P by striking out all of section 1 (page 326, lines 26 to 33 in amendment) and inserting in its place the following:

'Sec. P-1. 27 MRSA §83, sub-§§3 and 4, as amended by PL 1991, c. 622, Pt. V, §2, are further amended to read:

3. Delegate powers. To delegate powers to the Museum Director necessary for the administration of this chapter; and

4. Recommendations. To make recommendations to the Maine State Cultural Affairs Council for such legislation as may be necessary to improve the functioning of the Maine State Museum; and.

Sec. P-2. 27 MRSA §83, sub-§5, as enacted by PL 1991, c. 622, Pt. V, §3, is repealed.'

Further amend the amendment by relettering or renumbering any nonconsecutive Part letter or section number to read consecutively.



Assuming the Legislature through future legislation, or the Governor by curtailment of allotments, brings the General Fund budget for fiscal year 2002-03 into balance as required, this amendment increases the General Fund cost of the bill by \$44,000 for the 2004-2005 biennium. Based on the current projected balance, a balanced budget is maintained during the 2004-2005 biennium.
