48	This bill provides that, for purposes of determining whether beneficiaries of a law enforcement officer are entitled to the
50	accidental death benefit provided by the Maine State Retirement

- System, a law enforcement officer is presumed to have died in the course of employment if the officer dies as a result of hypertension or heart disease and a prior physical examination
- hypertension or heart disease, and a prior physical examination 4 at the time the member became a law enforcement officer or after had not shown evidence of hypertension or heart disease.
