for the sale of water. In the event the parties are unable to 2 agree upon a rate, the water utility seeking to purchase water may petition the commission to establish rates and terms for the sale of water.'

## **SUMMARY**

10 This amendment accomplishes 3 things. First, it changes the requirement that the pilot project include a water utility from one serving more than 100,000 people to one serving more than 12 25,000 people. Second, it reduces the number of participants in 14 the pilot project from 10% of the consumer-owned water utilities operating in the State to 8 utilities. Third, in the case of a locally governed water district's selling water to an adjacent 16 water utility at wholesale, the Public Utilities Commission retains jurisdiction to establish fair rates for the sale of 18 water by locally governed water districts. 20
