#### Sec. 5. 10 MRSA §2364-B, sub-§6 is enacted to read:

4 6. Presentation of trip ticket to forest ranger. Upon request, a truck driver shall present a copy of the trip ticket to a forest ranger. Upon request, a wood scaler shall present the б record of measurement including a copy of the trip ticket or information contained on the trip ticket to a forest ranger. A 8 forest ranger may request and use this information for the purpose of enforcing and investigating alleged violations of 10 Title 12, section 8883; Title 14, section 7552; and Title 17, section 2510. For purposes of this subsection, "forest ranger" 12 means a person employed by the Department of Conservation, Bureau of Forestry under Title 12, section 8901. A truck driver or wood 14 scaler who fails to comply with the provisions of this subsection is subject to the penalties provided in section 2368.' 16

- 18 Further amend the bill in section 2 by striking out all of paragraph R and inserting in its place the following:
- 'R. The director of the bureau may authorize certified
  employees of the bureau to serve civil process and represent
  the bureau in District Court in the prosecution of civil
  violations of chapter 805, subchapter 5; Title 14, section
  7552; and Title 17, sections 2510 and 3853-D. Certification
  of these employees must be as provided under Title 30-A,

## COMMITTEE AMENDMENT

COMMITTEE AMENDMENT "A" to H.P. 1059, L.D. 1447

2 Further amend the bill by relettering or renumbering any nonconsecutive Part letter or section number to read 4 consecutively.

#### SUMMARY

This amendment specifies certain civil violations that 10 forest rangers will be authorized to process. It also requires a trucker or wood scaler to present a trip ticket or record of 12 measurement to a forest ranger upon request. It allows the Director of the Bureau of Forestry within the Department of 14 Conservation to authorize forest rangers to be certified to represent the bureau in District Court for civil violations of forest notification and reporting requirements, civil trespass 16 violations and unlawful cutting violations. The amendment corrects an omission in the bill allowing certified forest 18 rangers to represent the Department of Conservation in court for 20 specific violations.

### **Fiscal Detail and Notes**

This bill will require General Fund appropriations of \$12,000 in fiscal year 2003-04 and \$3,000 annually thereafter to the State Planning Office for developing new exams, training expenses, printing and postage. This appropriation is required to implement the certification of a maximum of six Bureau of Forestry employees.
