38	This amendment deletes those provisions of the bill that raised the fee caps for dental hygienists, denturists and dental
40	radiographers. The amendment retains the provision that raises the fee cap for dentists. The amendment also raises the fee cap
42	for licensure of dentists with out-of-state licenses to \$400 rather than \$500 to be consistent with licensure of in-state
44	dentists, in order to avoid constitutional problems.
