COMMITTEE AMENDMENT "A" to S.P. 521, L.D. 1552, Bill, "An Act To Allocate a Portion of the Reed Act Distribution of 2002 To Use for the Administration of the Unemployment Insurance and Employment Services Programs"

Amend the bill by inserting after section 2 the following:

'Sec. 3. Appropriations and Allocations. The following appropriations and allocations are made.

**LABOR, DEPARTMENT OF**

**Employment Security Services 0245**

Initiative: Allocates funds associated with a portion of the federal Reed Act Distribution funds of 2002 being transferred from the Employment Security Administration Fund to maintain and operate the State's unemployment and employment offices.

**Fiscal Detail and Notes**

This bill includes Federal Expenditures Fund allocations of \$4,000,000 in fiscal year 2003-04 and \$1,560,000 in fiscal year 2004-05 for the Employment Security Services program within the Department of Labor associated with the 2002 Reed Act Distribution funds being transferred to this program. The Department of Labor anticipates transferring \$1,400,000 in fiscal year 2005-06 and \$1,400,000 in fiscal year 2006-07 for the continued support of the State's employment and unemployment offices. The \$1,400,000 balance of the \$9,760,000 in Reed Act Distribution funds authorized for use by this legislation will be drawn down in fiscal year 2007-08.
