COMMITTEE AMENDMENT "B" to S.P. 525, L.D. 1562, Bill, "An Act To Change the Name of the Augusta Mental Health Institute to "Riverview Psychiatric Center""

Amend the bill by striking out the title and substituting the following:

'An Act To Change the Name of the Augusta Mental Health Institute to "Riverview Center"'

Amend the bill in section 1 in that part designated "§3201." in the first paragraph in the last line (page 1, line 11 in L.D.) by striking out the following: "Psychiatric Center." and inserting in its place the following: 'Center. The commissioner shall dedicate a space in the Riverview Center to the memory of Dorothea Lynde Dix in recognition of her lifelong efforts to advocate for the just treatment of persons with mental illness.'

Further amend the bill in section 2 in the 4th line (page 1, line 16 in L.D.) by striking out the following: "Psychiatric"

Further amend the bill in section 3 in the first paragraph in the 5th line (page 1, line 24 in L.D.) by striking out the following: "Psychiatric" and in the 6th line (page 1, line 25 in L.D.) by striking out the following: "Psychiatric"

Further amend the bill in section 3 in the last paragraph in the 3rd line (page 1, line 34 in L.D.) by striking out the following: "Psychiatric"
