SUMMARY

This amendment reduces the bond issue in Part A of the amendment by \$1,000,000 by eliminating funds for the Mack Point site development project; increases the bond issue in Part B by \$800,000 by providing funds for grants to potato farmers for agricultural irrigation projects; and reduces the bond issue in Part C by \$3,500,000 by reducing funding to the University of Maine System, the Maine Maritime Academy and the School Revolving Renovation Fund and eliminating funding to the Maine State Library.

Fiscal Detail and Notes

This amendment reduces the amount of bonds authorized by \$3,700,000 to a new total of \$90,100,000. The transportation bond is reduced by \$1,000,000, the environmental bond is increased by \$800,000 and the education bond is reduced by \$3,500,000. The net change is expressed below.
