SENATE AMENDMENT "D" to COMMITTEE AMENDMENT "A" to S.P. 531, L.D. 1572, Bill, "An Act To Authorize Department of Transportation Bond Issues in the Amount of \$75,000,000 for Improvements to Highways; Bridges; Airports; State-owned Ferry Vessels; Ferry and Port Facilities; Port and Harbor Structures; Development of Rail Corridors; Improvements to Railroad Structures and Intermodal Facilities; Investment in Public Transportation Fleet and Public Park and Ride and Service Facilities; and Statewide Trail and Pedestrian Improvements"

Amend the amendment by striking out the substitute title and replacing it with the following:

'An Act To Authorize Bond Issues in the Total Amount of \$103,800,000, of Which \$70,800,000 Is for a Transportation Bond Issue for Transportation Improvements and \$33,000,000 Is for General Fund Bond Issues for Pollution Control and Cleanup, School Renovations and Improvement of Postsecondary Education Facilities'

Further amend the amendment in Part A in section 1 in the 4th line (page 2, line 6 in amendment) by striking out the following: "\$60,800,000" and inserting in its place the following: '\$70,800,000'

Further amend the amendment in Part A in section 6 in that part designated "TRANSPORTATION, DEPARTMENT OF" in that part designated "General Fund" in the 2nd line (page 3, line 7 in amendment) by striking out the following: "26,100,000" and inserting in its place the following: '36,100,000'

Further amend the amendment in Part A in section 6 in that part designated "TRANSPORTATION, DEPARTMENT OF" in that part designated "General Fund" in the last line (page 3, line 13 in amendment) by striking out the following: "\$44,050,000" and inserting in its place the following: '\$54,050,000'



This amendment increases the amount of bonds authorized by \$10,000,000 to a new total of \$103,800,000. The transportation bonds are increased by \$10,000,000. The net change is expressed below.
