COMMITTEE AMENDMENT "A" to H.P. 1175, L.D. 1602, Bill, "An Act To Revise and Amend Certain Public Health Laws"

Amend the bill in section 1 in that part designated "**§1101-A.**" in subsection 3 in the last line (page 1, line 22 in L.D.) by inserting after the following: "mausoleum" the following: 'of no more than 6 crypts'

Further amend the bill in section 3 in subsection 1 in the 2nd line (page 1, line 38 in L.D.) by striking out the following: "home child care" and inserting in its place the following: 'the premises of a home day care'

Further amend the bill in section 6 in the 3rd line (page 2, line 22 in L.D.) by inserting after the following: "child care facility" the following: ', premises of a home day care provider'

Further amend the bill in section 7 in subsection 1 in the 3rd line (page 2, line 30 in L.D.) by striking out the following: "center" and inserting in its place the following: 'center facility, premises of the home day care provider'

Further amend the bill in section 8 in subsection 4 in the 4th line (page 8, line 41 in L.D.) by inserting after the following: "~~center--facility,~~" the following: 'premises of the home day care provider,'

Further amend the bill in section 10 in that part designated "**§1326.**" in the last line (page 3, line 38 in L.D.) by striking out the following: "center" and inserting in its place the following: 'facility, premises of the home day care provider'
