2 **Be it enacted by the People of the State of Maine as follows:**

4 **Sec. 1. 30-A MRSA §66**, as repealed by PL 2003, c. 43, §2 and
as amended by PL 2003, c. 62, §3 and affected by §§5 and 6, is
6 repealed.

8 **Sec. 2. 30-A MRSA §66-A** is enacted to read:

10 **§66-A. County commissioner districts**

12 **1. Creation of Androscoggin County Commissioner Districts.**

Androscoggin County is divided into the following 3 districts.

14 A. Commissioner District Number 1, in the County of
16 Androscoggin, consists of the minor civil divisions of
Durham, Greene, Leeds, Lisbon, Livermore, Livermore Falls,
18 Sabattus, Turner and Wales. The term of office of the
county commissioner from this district expires in 2004 and
every 4 years thereafter.

20 B. Commissioner District Number 2, in the County of
22 Androscoggin, consists of the minor civil divisions of
Auburn, Mechanic Falls, Minot and Poland. The term of
24 office of the county commissioner from this district expires
in 2004 and every 4 years thereafter.

26 C. Commissioner District Number 3, in the County of
28 Androscoggin, consists of the minor civil division of
Lewiston. The term of office of the county commissioner
30 from this district expires in 2006 and every 4 years
thereafter.

32 **2. Creation of Aroostook County Commissioner Districts.**

34 Aroostook County is divided into the following 3 districts.

36 A. Commissioner District Number 1, in the County of
38 Aroostook, consists of the minor civil divisions of Amity,
Bancroft, Blaine, Bridgewater, Cary Plantation, Crystal,
40 Dyer Brook, Easton, Fort Fairfield, Glenwood Plantation,
Hammond, Haynesville, Hersey, Hodgdon, Houlton, Island
42 Falls, Linneus, Littleton, Ludlow, Macwahoc Plantation, Mars
Hill, Merrill, Monticello, Moro Plantation, New Limerick,

2 Oakfield, Orient, Oxbow Plantation, Penobscot Indian Island
3 Reservation, Reed Plantation, Sherman, Smyrna and Weston and
4 the unorganized territories of Central Aroostook and South
5 Aroostook. The term of office of the county commissioner
6 from this district expires in 2006 and every 4 years
7 thereafter.

8 B. Commissioner District Number 2, in the County of
9 Aroostook, consists of the minor civil divisions of Ashland,
10 Caribou, Castle Hill, Chapman, Garfield Plantation,
11 Mapleton, Masardis, Presque Isle, Washburn and Westfield and
12 the unorganized territory of Northwest Aroostook. The term
13 of office of the county commissioner from this district
14 expires in 2004 and every 4 years thereafter.

15 C. Commissioner District Number 3, in the County of
16 Aroostook, consists of the minor civil divisions of
17 Allagash, Caswell, Cyr, Eagle Lake, Fort Kent, Frenchville,
18 Grand Isle, Hamlin, Limestone, Madawaska, Nashville, New
19 Canada, New Sweden, Perham, Portage Lake, St. Agatha, St.
20 Francis, St. John, Stockholm, Van Buren, Wade, Wallagrass,
21 Westmanland, Winterville and Woodland and the unorganized
22 territories of Connor and Square Lake. The term of office
23 of the county commissioner from this district expires in
24 2004 and every 4 years thereafter.

25 3. Creation of Cumberland County Commissioner Districts.
26 Cumberland County is divided into the following 3 districts.

27 A. Commissioner District Number 1, in the County of
28 Cumberland, consists of the minor civil divisions of
29 Cumberland, Falmouth, Long Island, Portland and Yarmouth.
30 The term of office of the commissioner from this district
31 expires in 2004 and every 4 years thereafter.

32 B. Commissioner District Number 2, in the County of
33 Cumberland, consists of the minor civil divisions of Cape
34 Elizabeth, Frye Island, Gorham, Scarborough, South Portland,
35 Standish and Westbrook. The term of office of the
36 commissioner from this district expires in 2004 and every 4
37 years thereafter.

38 C. Commissioner District Number 3, in the County of
39 Cumberland, consists of the minor civil divisions of
40 Baldwin, Bridgton, Brunswick, Casco, Freeport, Gray,
41 Harpswell, Harrison, Naples, New Gloucester, North Yarmouth,
42 Pownal, Raymond, Sebago and Windham. The term of office of
43 the commissioner from this district expires in 2006 and
44 every 4 years thereafter.

4. Creation of Franklin County Commissioner Districts.

Franklin County is divided into the following 3 districts.

A. Commissioner District Number 1, in the County of Franklin, consists of the minor civil divisions of Carthage, Jay and Wilton. The term of office of the commissioner from this district expires in 2004 and every 4 years thereafter.

B. Commissioner District Number 2, in the County of Franklin, consists of the minor civil divisions of Chesterville, Farmington and New Sharon. The term of office of the commissioner from this district expires in 2004 and every 4 years thereafter.

C. Commissioner District Number 3, in the County of Franklin, consists of the minor civil divisions of Avon, Carrabassett Valley, Coplin Plantation, Dallas Plantation, Eustis, Industry, Kingfield, Madrid, New Vineyard, Phillips, Rangeley, Rangeley Plantation, Sandy River Plantation, Strong, Temple and Weld and the unorganized territories of East Central Franklin, North Franklin, South Franklin, West Central Franklin and Wyman. The term of office of the commissioner from this district expires in 2006 and every 4 years thereafter.

5. Creation of Hancock County Commissioner Districts.

Hancock County is divided into the following 3 districts.

A. Commissioner District Number 1, in the County of Hancock, consists of the minor civil divisions of Amherst, Aurora, Blue Hill, Eastbrook, Ellsworth, Gouldsboro, Great Pond, Mariaville, Osborn, Otis, Sorrento, Sullivan, Surry, Waltham and Winter Harbor and the unorganized territories of Central Hancock, East Hancock and Northwest Hancock. The term of office of the commissioner from this district expires in 2004 and every 4 years thereafter.

B. Commissioner District Number 2, in the County of Hancock, consists of the minor civil divisions of Brooklin, Brooksville, Bucksport, Castine, Dedham, Deer Isle, Orland, Penobscot, Sedgwick, Stonington and Verona. The term of office of the commissioner from this district expires in 2006 and every 4 years thereafter.

C. Commissioner District Number 3, in the County of Hancock, consists of the minor civil divisions of Bar Harbor, Cranberry Isles, Franklin, Frenchboro, Hancock, Lamoine, Mount Desert, Southwest Harbor, Swan's Island, Tremont and Trenton. The term of office of the commissioner

2 from this district expires in 2004 and every 4 years
3 thereafter.

4 **6. Creation of Kennebec County Commissioner Districts.**
5 Kennebec County is divided into the following 3 districts.

6 A. Commissioner District Number 1, in the County of
7 Kennebec, consists of the minor civil divisions of Augusta,
8 Chelsea, China, Pittston, Randolph, Sidney, Vassalboro and
9 Windsor. The term of office of the commissioner from this
10 district expires in 2004 and every 4 years thereafter.

11 B. Commissioner District Number 2, in the County of
12 Kennebec, consists of the minor civil divisions of Belgrade,
13 Farmingdale, Fayette, Gardiner, Hallowell, Litchfield,
14 Manchester, Monmouth, Mount Vernon, Readfield, Rome, Vienna,
15 Wayne, West Gardiner and Winthrop. The term of office of
16 the commissioner from this district expires in 2006 and
17 every 4 years thereafter.

18 C. Commissioner District Number 3, in the County of
19 Kennebec, consists of the minor civil divisions of Albion,
20 Benton, Clinton, Oakland, Waterville and Winslow and the
21 unorganized territory of Unity. The term of office of the
22 commissioner from this district expires in 2004 and every 4
23 years thereafter.

24 **7. Creation of Knox County Commissioner Districts.** Knox
25 County is divided into the following 3 districts.

26 A. Commissioner District Number 1, in the County of Knox,
27 consists of the minor civil divisions of Owls Head,
28 Rockland, Rockport and South Thomaston. The term of office
29 of the commissioner from this district expires in 2006 and
30 every 4 years thereafter.

31 B. Commissioner District Number 2, in the County of Knox,
32 consists of the minor civil divisions of Cushing,
33 Friendship, St. George, Thomaston and Warren. The term of
34 office of the commissioner from this district expires in
35 2004 and every 4 years thereafter.

36 C. Commissioner District Number 3, in the County of Knox,
37 consists of the minor civil divisions of Appleton, Camden,
38 Hope, Isle au Haut, Matinicus Isle Plantation, North Haven,
39 Union, Vinalhaven and Washington and the unorganized
40 territory of Criehaven. The term of office of the
41 commissioner from this district expires in 2004 and every 4
42 years thereafter.

8. Creation of Lincoln County Commissioner Districts.

Lincoln County is divided into the following 3 districts.

A. Commissioner District Number 1, in the County of Lincoln, consists of the minor civil divisions of Boothbay, Boothbay Harbor, Edgecomb, Southport, Westport Island and Wiscasset. The term of office of the commissioner from this district expires in 2004 and every 4 years thereafter.

B. Commissioner District Number 2, in the County of Lincoln, consists of the minor civil divisions of Bremen, Bristol, Monhegan Plantation, Nobleboro, South Bristol and Waldoboro. The term of office of the commissioner from this district expires in 2006 and every 4 years thereafter.

C. Commissioner District Number 3, in the County of Lincoln, consists of the minor civil divisions of Alna, Damariscotta, Dresden, Jefferson, Newcastle, Somerville and Whitefield and the unorganized territory of Hibberts Gore. The term of office of the commissioner from this district expires in 2004 and every 4 years thereafter.

9. Creation of Oxford County Commissioner Districts.

Oxford County is divided into the following 3 districts.

A. Commissioner District Number 1, in the County of Oxford, consists of the minor civil divisions of Bethel, Brownfield, Denmark, Fryeburg, Hanover, Hiram, Lovell, Norway, Porter, Stow, Sweden and Waterford and in the unorganized territory of South Oxford the following census units: Block 1032, Block 1033, Block 1034, Block 1035, Block 1036, Block 1037, Block 1038, Block 1039, Block 1040, Block 1041, Block 1196, Block 1197, Block 1198, Block 1199, Block 1200, Block 1201, Block 1202, Block 1203, Block 1204, Block 1205 and Block 1208 of Tract 996000. The term of office of the commissioner from this district expires in 2004 and every 4 years thereafter.

B. Commissioner District Number 2, in the County of Oxford, consists of the minor civil divisions of Andover, Byron, Canton, Dixfield, Gilead, Hartford, Lincoln Plantation, Magalloway Plantation, Mexico, Newry, Peru, Roxbury, Rumford, Sumner and Upton and the unorganized territories of Milton and North Oxford. The term of office of the commissioner from this district expires in 2004 and every 4 years thereafter.

C. Commissioner District Number 3, in the County of Oxford, consists of the minor civil divisions of Buckfield, Greenwood, Hebron, Otisfield, Oxford, Paris, Stoneham, West

2 Paris and Woodstock and in the unorganized territory of
3 South Oxford the following census units: Block 1023, Block

48 office of the commissioner from this district expires in
2004 and every 4 years thereafter.

2 office of the commissioner from this district expires in
3 2004 and every 4 years thereafter.

4 C. Commissioner District Number 3, in the County of
5 Sagadahoc, consists of the minor civil divisions of
6 Arrowsic, Bath and West Bath. The term of office of the
7 commissioner from this district expires in 2006 and every 4
8 years thereafter.

10 **13. Creation of Somerset County Commissioner Districts.**
11 **Somerset County is divided into the following 3 districts.**

12 A. Commissioner District Number 1, in the County of
13 Somerset, consists of the minor civil divisions of Anson,
14 Athens, Bingham, Brighton Plantation, Cambridge, Caratunk,
15 Dennistown Plantation, Embden, Harmony, Hartland, Highland
16 Plantation, Jackman, Moose River, Moscow, New Portland,
17 Palmyra, Pleasant Ridge Plantation, Ripley, St. Albans,
18 Starks, The Forks Plantation and West Forks Plantation and
19 the unorganized territories of Central Somerset, Northeast
20 Somerset, Northwest Somerset and Seboomook Lake Plantation.
21 The term of office of the commissioner from this district
22 expires in 2004 and every 4 years thereafter.

23 B. Commissioner District Number 2, in the County of
24 Somerset, consists of the minor civil divisions of
25 Fairfield, Madison, Mercer, Norridgewock, Smithfield and
26 Solon. The term of office of the commissioner from this
27 district expires in 2004 and every 4 years thereafter.

28 C. Commissioner District Number 3, in the County of
29 Somerset, consists of the minor civil divisions of Canaan,
30 Cornville, Detroit, Pittsfield and Skowhegan. The term of
31 office of the commissioner from this district expires in
32 2006 and every 4 years thereafter.

33 **14. Creation of Waldo County Commissioner Districts.** Waldo
34 **County is divided into the following 3 districts.**

35 A. Commissioner District Number 1, in the County of Waldo,
36 consists of the minor civil divisions of Belfast, Belmont,
37 Islesboro, Lincolnville, Northport and Waldo. The term of
38 office of the commissioner from this district expires in
39 2006 and every 4 years thereafter.

40 B. Commissioner District Number 2, in the County of Waldo,
41 consists of the minor civil divisions of Frankfort, Jackson,
42 Monroe, Prospect, Searsport, Stockton Springs, Swanville and
43 Winterport. The term of office of the commissioner from
44 this district expires in 2004 and every 4 years thereafter.

2 C. Commissioner District Number 3, in the County of Waldo,
3 consists of the minor civil divisions of Brooks, Burnham,
4 Freedom, Knox, Liberty, Montville, Morrill, Palermo,
5 Searsmont, Thorndike, Troy and Unity. The term of office of
6 the commissioner from this district expires in 2004 and
7 every 4 years thereafter.

8
9 **15. Creation of Washington County Commissioner Districts.**
10 Washington County is divided into the following 3 districts.

11 A. Commissioner District Number 1, in Washington County,
12 consists of the minor civil divisions of Alexander,
13 Baileyville, Baring, Beddington, Calais, Charlotte,
14 Codyville Plantation, Cooper, Crawford, Danforth, Deblois,
15 Dennysville, Grand Lake Stream Plantation, Meddybemps,
16 Northfield, Passamaquoddy Indian Township Reservation,
17 Princeton, Robbinston, Talmadge, Topsfield, Vanceboro, Waite
18 and Wesley and the unorganized territory of North
19 Washington. The term of office of the commissioner from
20 this district expires in 2004 and every 4 years thereafter.

21 B. Commissioner District Number 2, in Washington County,
22 consists of the minor civil divisions of Cutler, East
23 Machias, Eastport, Lubec, Machias, Passamaquoddy Pleasant
24 Point Reservation, Pembroke, Perry and Whiting and the
25 unorganized territory of East Central Washington. The term
26 of office of the commissioner from this district expires in
27 2004 and every 4 years thereafter.

28 C. Commissioner District Number 3, in Washington County,
29 consists of the minor civil divisions of Addison, Beals,
30 Centerville, Cherryfield, Columbia, Columbia Falls,
31 Harrington, Jonesboro, Jonesport, Machiasport, Marshfield,
32 Milbridge, Roque Bluffs, Steuben and Whitneyville. The term
33 of office of the commissioner from this district expires in
34 2006 and every 4 years thereafter.

35 **16. Creation of York County Commissioner Districts.**
36 York County is divided into the following 5 districts.

37 A. Commissioner District Number 1, in the County of York,
38 consists of the minor civil divisions of Acton, Berwick,
39 Buxton, Cornish, Hollis, Lebanon, Limerick, Limington,
40 Newfield and Parsonsfield. The term of office of the
41 commissioner from this district expires in 2006 and every 4
42 years thereafter.

43 B. Commissioner District Number 2, in the County of York,
44 consists of the minor civil divisions of Arundel, Biddeford,
45 and York. The term of office of the commissioner from this
46 district expires in 2006 and every 4 years thereafter.

2 Kennebunk and Kennebunkport. The term of office of the
3 commissioner from this district expires in 2006 and every 4
4 years thereafter.

6 C. Commissioner District Number 3, in the County of York,
7 consists of the minor civil divisions of Dayton, Lyman, Old
8 Orchard Beach, Saco and Waterboro. The term of office of
9 the commissioner from this district expires in 2006 and
10 every 4 years thereafter.

12 D. Commissioner District Number 4, in the County of York,
13 consists of the minor civil divisions of Alfred, North
14 Berwick, Sanford, Shapleigh and South Berwick. The term of
15 office of the commissioner from this district expires in
16 2004 and every 4 years thereafter.

18 E. Commissioner District Number 5, in the County of York,
19 consists of the minor civil divisions of Eliot, Kittery,
20 Ogunquit, Wells and York. The term of office of the
21 commissioner from this district expires in 2004 and every 4
22 years thereafter.

24 SUMMARY

26 This bill carries out the legislative intent of Public Law
27 2003, chapter 43 by specifying, per United States Census
28 designations, those areas that are located in each county
29 commissioner district as reapportioned by the apportionment
30 commission and submitted to the Clerk of the House April 3, 2003.
