Further amend the amendment in Part A in section 8 in that 26 part designated "**§6910.**" in subsection 1 in the 3rd line (page 15, line 25 in amendment) by inserting after the following: 28 "<u>2004.</u>" the following: '<u>After Dirigo Health Insurance has been operational for one year, the board shall seek Legislative 30 approval for expansion to a statewide basis.'</u>

#### 'PART H

Sec. H-1. Transfer. Notwithstanding any other provision of law, the State Controller shall transfer \$10,600,000 from the unappropriated surplus of the General Fund to the Dirigo Health Fund in a manner to be determined in consultation with the Executive Director of Dirigo Health but in no case later than June 30, 2004.

### **Fiscal Detail and Notes**
