22	Amend the bill in section 1 in that part designated " <b>Sec. 1.</b> " by striking out all of the first blocked paragraph after
24	subsection 6 (page 2, lines 21 to 34 in L.D.) and inserting in its place the following:
26	'shallbeandherebyareeenstituted and surrounding areas
28	described as follows: Beginning at a point where the New Portland-Embden town line intersects with the Lexington town
30	<u>line; thence south along the New Portland-Embden town line to the</u> intersection of 44° 54′ 30″ north latitude; thence west along 44°
32	54' 30" north latitude to the intersection of 70° 04' 37" west longitude; thence north along 70° 04' 37" west longitude to the
34	Lexington town line; thence east along the Lexington town line to the point of beginning constitute a body politic and corporate

## COMMITTEE AMENDMENT

COMMITTEE AMENDMENT "H" to H.P. 1199, L.D. 1620

Portland Water District as proposed in this Act at a special or regular town meeting or election held prior to January 1, 2005. 2 The election must be called, advertised and conducted according to the law relating to municipal elections, except that the 4 registrar of voters is not required to prepare or the clerk to post a new list of voters. The registrar of voters must be in б session on the secular day next preceding the election. The town clerk shall prepare the required ballots, on which the town clerk 8 shall reduce the subject matter of this Act to the following 10 question:

- 12 "Do you favor expanding the territory of the New Portland Water District to allow the district to access a new source 14 of water supply?"
- 16 The voters shall indicate by a cross or check mark placed against the word "Yes" or "No" their opinion on the question.
- The results must be declared by the municipal officers of 20 the Town of New Portland and due certificate of the results filed by the town clerk with the Secretary of State.

This Act takes effect immediately upon its acceptance by a majority of the legal voters voting at the election. Failure of 24 acceptance by a majority of the legal voters does not prohibit subsequent elections held in accordance with this section, 26 provided the elections are held prior to January 1, 2005.'
