## 12 This amendment requires notices of liability to be sent by certified mail, return receipt requested. It also requires a violation clerk designated by the Maine Turnpike Authority to send a notice of an appeal hearing by certified mail, return 16 receipt requested. It requires the authority to send a notice to the registered owner when the Secretary of State is being 18 notified to suspend a registration for nonpayment of turnpike tolls.
