An Act To Amend the Medicaid Drug Rebate Program and the Elderly Low-cost Drug Program

Be it enacted by the People of the State of Maine as follows:

Sec. 1. 22 MRSA §254, sub-§4-A, as amended by PL 2003, c. 20, 4 Pt. GGG, §3, is further amended to read:

6 Payment for drugs provided. 4-A. The commissioner may establish the amount of payment to be made by recipients toward 8 the cost of prescription or nonprescription drugs, medication and medical supplies furnished under this program as long as, for persons at or below 185% of the federal poverty line, the total 10 cost of covered purchase for any а prescription or nonprescription drug or medication provided under the basic 12 component of the program or the total cost of any covered 14 purchase of a generic prescription drug or medication under the supplemental component of the program does not exceed the sum of 16 \$2 plus 20% of the price allowed for that prescription under program rules. For the supplemental component of the program_ 18 except as otherwise provided in this subsection, the total cost paid by the individual for any covered purchase of a prescription 20 drug or medication may not exceed the cost of the program for that drug or medication minus the \$2 paid by the program. The 22 commissioner shall establish annual limits on the costs incurred by eligible household members for prescriptions or 24 nonprescription drugs or medications covered under the program on or prior to May 31, 2001, after which the program must pay 80% of 26 the cost of all prescriptions or nonprescription drugs or medications covered by the supplemental component of the program on May 31, 2001 minus \$2.
