- 14 SENATE AMENDMENT "A" to COMMITTEE AMENDMENT "A" to H.P. 16 1285, L.D. 1763, Bill, "An Act To Promote Responsible Pet Ownership"
- Amend the amendment by striking out all of section 6 and 20 inserting in its place the following:

'Sec. 6. Administrative costs to be reimbursed. The Department of 22 Administrative and Financial Services, Bureau of Revenue Services 24 shall absorb within existing resources any administrative costs implementation involved in the initial of this Act. Notwithstanding the Maine Revised Statutes, Title 7, section 26 3910-B, subsection 1 or any other provision of law, the 28 Commissioner of Agriculture, Food and Rural Resources must transfer from the Companion Animal Sterilization Fund established 30 in Title 7, section 3910-B an amount determined by the State Tax Assessor to be the additional administrative costs associated 32 with the implementation of this Act. The State Tax Assessor is authorized to deposit the funds received as reimbursement for costs incurred in an Other Special Revenue Funds account within 34 the Bureau of Revenue Services to be used to support the 36 operations of the bureau necessary for the implementation of this Act. 38

Fiscal Detail and Notes

This amendment reduces the General Fund cost of the bill by \$10,791 in fiscal year 2004-05. It also adds an Other Special Revenue funds allocation of \$10,791 in the event revenue is available for transfer from the Companion Animal Sterilization Fund to reimburse the costs incurred by Maine Revenue Services.
