Amend the amendment on page 3 in Part A, section 4 by striking out all of the first line (page 3, line 11 in amendment) and inserting in its place the following:

'Sec. A-4. 8 MRSA §299 is enacted to read:'

Further amend the amendment in Part A, section 4 by striking out all of that part designated "§300." (page 3, lines 41 to 50 and page 4, lines 1 to 5 in amendment)

Further amend the amendment on page 15 by striking out all of paragraph D (page 15, lines 14 to 17 in amendment) and inserting in its place the following:

'D. Five percent of the total gross slot machine income must be forwarded by the board to the Treasurer of State, who shall credit the money to the Agricultural Fair Support Fund established in Title 7, section 77. Forty-eight months after the Treasurer of State receives the first allocation, the percent of total slot machine income forwarded to the Agricultural Fair Support Fund is reduced to 4% with the remaining 1% to be forwarded to the State in accordance with subsection 1;


