12 This amendment provides that benefits for prosthetic devices under health plans issued for use in connection with health 14 savings accounts as authorized under Title XII of the Medicare Prescription Drug, Improvement, and Modernization Act of 2003 may 16 be subject to the same deductibles and out-of-pocket limits that apply to overall benefits under the contract. 18
