'PART FFFF

Sec. FFFF-1. Change to University of Maine System. Notwithstanding any law to the contrary, the University of Maine 28 System may not reorganize, close or change the name of any 30 campus, center, college or program without providing notification to the Legislature of the reorganization, closure or name change, and in on case sooner than the report by the Chancellor of the 32 University of Maine System to the Legislature in 2005 pursuant to the Maine Revised Statutes, Title 20-A, section 10902-B.' 34

- 36 Further amend the amendment by relettering or renumbering any nonconsecutive Part letter or section number to read 38 consecutively.
