SENATE AMENDMENT "M" to COMMITTEE AMENDMENT "A" to H.P. 1420, L.D. 1919, Bill, "An Act To Make Supplemental Appropriations and Allocations for the Expenditures of State Government and To Change Certain Provisions of the Law Necessary to the Proper Operations of State Government for the Fiscal Years Ending June 30, 2004 and June 30, 2005"

Amend the amendment by inserting after Part EEEE the following:

PART FFFF

Sec. FFFF-1. Transfer of funds; Office of Licensing and Registration; Emergency Services Communication. Notwithstanding any other provision of law, the State Controller shall transfer \$1,043,460 from the Office of Licensing and Registration, Other Special Revenue Funds account in the Department of Professional and Financial Regulation to the Emergency Services Communication, Other Special Revenue Funds account in the Public Utilities Commission no later than June 30, 2005. It is the intent of the Legislature that this transfer of funds may not result in an increase in fees assessed for this purpose.'

Further amend the amendment by relettering or renumbering any nonconsecutive Part letter or section number to read consecutively.
