### Fiscal Detail and Notes

This bill includes General Fund appropriations of \$199,101 in both fiscal year 2005-06 and fiscal year 2006-07 for the Adult Education program within the Department of Education. These amounts are based on General Fund appropriations for the Adult Education program included in the Governor's Current Services budget of \$4,977,534 in fiscal year 2005-06 and \$4,977,534 in fiscal year 2006-07. Appropriations may need to be adjusted to reflect decisions made regarding the Governor's budget. General Fund appropriations are projected to grow 2% per year in fiscal years 2007-08 and 2008-09, respectively.
