COMMITTEE AMENDMENT "A" to H.P. 87, L.D. 111, Bill, "An Act To Promote Health Insurance Coverage for Employees of Small Businesses"

Amend the bill in section 2 in subsection 11-A in the 8th line (page 1, line 15 in L.D.) by striking out the following: "paragraph C" and inserting in its place the following: 'paragraph E'

Further amend the bill in section 2 in subsection 11-A in the 11th to 13th lines (page 1, lines 18 to 20 in L.D.) by striking the following: "or, at the member's or employee's option, to convert to a policy of individual coverage without evidence of insurability"

Further amend the bill in section 2 in subsection 11-A in paragraph L in subparagraph (3) in the last line (page 3, line 17 in L.D.) by inserting after the following: "policy" the following: 'except as provided in this subsection as to modification of benefits'

SUMMARY

This amendment is the minority report of the committee. The amendment removes unnecessary references to the conversion of an individual policy and corrects a cross-reference.
