HOUSE AMENDMENT "T" to COMMITTEE AMENDMENT "A" to H.P. 343, L.D. 468, Bill, "An Act Making Unified Appropriations and Allocations for the Expenditures of State Government, General Fund and Other Funds, and Changing Certain Provisions of the Law Necessary to the Proper Operations of State Government for the Fiscal Years Ending June 30, 2006 and June 30, 2007"

Amend the amendment in Part LL in section 6 in that part relating to "LEGISLATURE" by striking out all of the first part relating to "Legislature" (page 273, lines 39 to 49 and page 274, lines 1 to 4 in amendment)

Further amend the amendment in Part LL in section 6 by striking out all of the last 3 lines (page 275, lines 47 to 49 in amendment) and inserting in their place the following:

Further amend the amendment by adding after Part PPPP the following:


