SENATE AMENDMENT "L" to COMMITTEE AMENDMENT "A" to H.P. 343, L.D. 468, Bill, "An Act Making Unified Appropriations and Allocations for the Expenditures of State Government, General Fund and Other Funds, and Changing Certain Provisions of the Law Necessary to the Proper Operations of State Government for the Fiscal Years Ending June 30, 2006 and June 30, 2007"

Amend the amendment by adding after Part PPPP the following:

PART QQQQ

Sec. QQQQ-1. Designation of funds for hospitals. Notwithstanding any other provision of law, of the state funds appropriated and allocated in Part A of this Act to the Department of Health and Human Services, Medical Care - Payments to Providers account, a minimum of \$111,391,728 is designated in fiscal year 2005-06 and \$120,345,372 in fiscal year 2006-07 for the state share of MaineCare prospective interim payments to hospitals. In addition, of the state funds appropriated and allocated in Part A of this Act to the Department of Health and Human Services, Medical Care - Payments to Providers account, a minimum of \$17,000,000 in fiscal year 2005-06 and \$17,000,000 in fiscal year 2006-07 is designated for the state share of MaineCare interim and final settlement payments to hospitals.'

Further amend the amendment by relettering or renumbering any nonconsecutive Part letter or section number to read consecutively.
