12 SUMMARY

This amendment requires the prescription drug program to operate within the limits of federal law and regulation and state law and rule and authorizes it to operate when permitted by federal law or under a federal waiver. The amendment requires the Department of Health and Human Services to specifically approve the use of any pharmacy outside the country that is used by the program.
