## SUMMARY

This amendment replaces the bill. The amendment creates a 10 resolve that directs the Department of Health and Human Services, Bureau of Health, in cooperation with the Maine Coalition Against Sexual Assault, the Maine State Police, the Maine Youth Camping 12 Association and the YMCA Alliance of Maine, to evaluate the effectiveness of the bureau's rules concerning camp counselor 14 hiring practices to protect children attending youth camps from sexual abuse. No later than January 15, 2006, the Bureau of 16 Health shall report its findings and any proposed recommendations regarding camp counselor hiring practices to protect children 18 attending youth camps from sexual abuse to the Joint Standing Committee on Criminal Justice and Public Safety. Upon receiving 20 the bureau's recommendations, the Joint Standing Committee on Criminal Justice and Public Safety may report out implementing 22 legislation if necessary. 24
