municipality provide the municipality with a copy of that wording electronically or by other means. The commissioner is not responsible for providing the safe zone informational sign.' '

SUMMARY

8 This amendment replaces the committee amendment and makes it clear that a municipality may, but is not required to, post 10 certain areas that minors frequent as safe zones. A municipality may do this by posting an informational sign in a conspicuous 12 place. The Commissioner of Public Safety shall establish uniform wording to be used on the signs and provide the wording to the 14 municipalities. The commissioner is not responsible for providing the signs.

Removal of cost and revenue for signs - General Fund

Fiscal Detail and Notes

Eliminating the requirement that the Department of Public Safety provide signs for safe zones and that reimbursement come from municipalities will eliminate the General Fund costs and revenue from that activity. As amended, the bill still expands Class A, B and C crimes and continues to have correctional and judicial impacts.
