The department shall make 2 available for public inspection and photocopying copies of all documents required by this section and shall post those documents 4 on the department's publicly accessible website.' 6 SUMMARY 8 This amendment replaces the bill. The amendment requires the annual public disclosure of federal Internal Revenue Service 10 Form 990 for each hospital and for each tax-exempt entity related 12 to that hospital that is required by federal law to submit that form to the Internal Revenue Service. The amendment also 14 requires hospitals to annually publicly disclose the federal Service Form 1120 for Internal Revenue each for-profit corporation in which the hospital has a controlling interest. 16 This information must be submitted annually to the Department of Health and Human Services, which must make the information 18 available to the public for inspection and photocopying and must post the information on its public website. 20 22 **FISCAL NOTE REOUIRED** (See attached)
