'Sec. 5. Duties. Resolved: That the commission may hold up to 4 meetings and shall study the following issues:

8 1. Whether law enforcement officers in the Office of the
 Attorney General and the Department of the Secretary of State
 10 should be included in the 1998 Special Plan;

2. Whether corrections officers and mental health workers should have uniform retirement benefits;

Whether corrections officers and mental health workers,
 regardless of their age, should be eligible to retire after 25 years of service without a reduction in benefits;

4. Which job classifications should be included in this 20 retirement plan, if the plan is recommended by the commission; and

5. Possible ways of funding these retirement plans, if the plans are recommended by the commission; and be it further'

SUMMARY

This amendment expands the study to include a review of whether law enforcement officers in the Office of the Attorney General and the Department of the Secretary of State should be included in the 1998 Special Plan, and changes the name, membership and duties of the commission accordingly.
