#### SUMMARY

This amendment is the minority report and requires a certificate of approval holder to have a prior business relationship with the wholesale business being acquired by the wholesale licensee before entering into a partnership with that wholesaler. It also specifically prohibits the certificate of approval holder from participating in the daily operations of the partnership.



### **Fiscal Detail and Notes**

The requirement that certain limited partnerships would be self terminating after 10 years will require a one-time additional General Fund appropriation of \$3,863 in fiscal year 2005-06 to the Department of the Secretary of State for the costs of reprogramming computer systems to allow proper tracking.
