20 Amend the amendment by inserting after the title the
22 following:

24 'Amend the resolve by striking out the title and
26 substituting the following:

28 '**Resolve, To Direct the Department of Conservation, Bureau of
30 Parks and Lands To Lease Certain Public Reserved Lands to the
32 Town of Allagash**'

34 Further amend the amendment in the first paragraph after the
36 title in the first line (page 1, line 23 in amendment) by
38 striking out the following: "Amend" and inserting in its place
40 the following: 'Further amend'

42 Further amend the amendment in the first paragraph after the
44 title in the first to 5th lines (page 1, lines 23 to 27 in
46 amendment) by striking out the following: "in section 1 in the
48 4th line (page 1, line 20 in L.D.) by striking out the
50 following: "4 parcels of land located in" and inserting in its
52 place the following: 'the public lot located in what was
formerly designated as T17 R11 WELS and is now within' " and
inserting in its place the following: 'by striking out everything
after the title and before the summary and inserting in its place
the following:

46 '**Sec. 1. Director of Bureau of Parks and Lands to enter into lease
48 agreement with Town of Allagash. Resolved:** That, with the approval
50 of the Town of Allagash, the Director of the Bureau of Parks and
52 Lands within the Department of Conservation shall lease to the
Town of Allagash the right to manage timber on 4 parcels of land
located in the Town of Allagash. The parcels of land to be
leased are those lots that were designated as ministerial and
school lots for Allagash Plantation and transferred to the State


2 for management as public reserved lands in accordance with Public
Law 1973, chapter 628 prior to the incorporation of Allagash
4 Plantation as the Town of Allagash in accordance with Private and
Special Law 1975, chapter 62.

6 The director and the Town of Allagash shall enter into a
lease agreement in accordance with the Maine Revised Statutes,
8 Title 12, section 1852, subsection 8 and upon terms negotiated
between the bureau and the town.'

12 Further amend the amendment by striking out everything after
the first paragraph after the title (page 1, lines 29 to 44 in
14 amendment)

16 **SUMMARY**

18 The bill, as amended by Committee Amendment "B," provides
for the Director of the Bureau of Parks and Lands to transfer one
20 public reserved lot to the Town of Allagash. This amendment
instead authorizes the Director of Parks and Lands to lease the
22 timber rights on 4 public reserved lots to the Town of Allagash.
