Amend the amendment in Part D in section 5 in the 3rd line (page 11, line 7 in amendment) by striking out the following: 'the Department of Education,'

Further amend the amendment in Part D in section 6 by striking out all of that part relating to "DEPARTMENT OF BUCATION" (page 12, lines 13 to 17 in amendment)

Further amend the amendment in Part D in section 6 in that part relating to "UNIVERSITY OF MAINE" in the 2nd blocked paragraph in the first line (page 12, line 24 in amendment) by striking out the following: "\$1,000,000" and inserting in its place the following: '\$2,000,000'

38 Further amend the amendment in Part D in section 10 by striking out all of the question (page 13, lines 15 to 29 in 40 amendment) and inserting in its place the following:

SUMMARY

This amendment removes the authorization for a \$1,000,000 10 bond issue for the development of the Sunrise Business and Career Center in the Town of Jonesboro and instead increases the 12 \$1,000,000 bond issue to renovate Camden Hall on the University of Maine Bangor campus for a graduate school for biomedical 14 science to \$2,000,000.


