Amend the amendment in Part B in section 1 in the 4th line (page 4, line 22 in amendment) by striking out the following: "\$12,000,000" and inserting in its place the following: '\$21,000,000'

Further amend the amendment in Part B in section 5 in subsection 6 in the first line (page 6, line 6 in amendment) by striking out the following: "Two" and inserting in its place the following: 'Eleven'

Further amend the amendment in Part B in section 7 under the caption "EXECUTIVE DEPARTMENT" in the 4th line (page 8, line 40 in amendment) by striking out the following: "\$12,000,000" and inserting in its place the following: '\$21,000,000'

Further amend the amendment in Part B in section 11 in the question in the first line (page 9, line 27 in amendment) by striking out the following: "\$12,000,000" and inserting in its place the following: '\$21,000,000'

Further amend the amendment in Part F in section 1 in the 4th line (page 16, line 19 in amendment) by striking out the following: "\$8,900,000" and inserting in its place the following: '\$10,900,000'

This amendment increases the total General Fund bond authorizations by a total of \$11,000,000 by authorizing an additional \$9,000,000 for preserving the working waterfront and an additional \$2,000,000 for the Farms For the Future Program.
