### **Fiscal Detail and Notes**

This amendment does the following:

1. It eliminates the General Fund bond authorizations totaling \$8,000,000 for the Marine Infrastructure and Technology Fund, the New Century Community Program, the Sunrise Business and Career Center and the career center facility at the University of Southern Maine's Lewiston-Auburn College.

2. It increases the General Fund bond authorizations by \$3,000,000 for the Small Enterprise Growth Fund and the Laboratory for Surface Science Technology.

3. It provides General Fund bond authorizations totaling \$5,000,000 for the Applied Technology Development Centers, the Maine Economic Recovery Loan Fund and the bioscience building at the University of Southern Maine.
