This bill establishes a Courthouse Security Fund to be administered by the Judicial Department. The Fund shall consist of any money appropriated or allocated for this purpose. An allocation of Other Special Revenue funds is included in fiscal year 2005-06 in the amount of \$500 in the event that additional funds are collected to support the activities of the Fund.
